

PERMISSION SLIP TO PLAY!

This is an Agreement between Puppy Love Daycare LLC (hereinafter called "PLD") and the pet owner whose signature appears below (hereinafter called "Owner").

AGE: Puppies are required to have received their first two sets of vaccinations, approximately 12 weeks of age. Once 6 months of age, all dogs must be spayed/neutered. Both new puppies & adopted adult dogs must be in their new home no less than 2 weeks before beginning a daycare program.

VACCINES: All dogs must have up-to-date vaccinations. Owners must submit verification of current DHPP, Rabies, and Bordetella.

FLEA: All dogs must be kept on regular flea control program. Any dog found to have fleas will be treated at the owner's expense.

COLLARS/TAGS/LEASHES: All dogs must wear a quick-release collar or harness with an ID tag, no buckle collars are allowed. If not in proper collar and tag, PLD will issue at the Owner's expense. When arriving and departing, all dogs must be on a fixed length leash (i.e. no retractable leashes).

HEALTH: Owners will certify that their dog(s) are in good health and have not been ill with a communicable condition in the last 30 days. During the period of this Agreement, Owner agrees to notify PLD of any known exposure of pet(s) to a communicable disease and hold pet out of attending PLD until pet(s) is symptom-free for a minimum of 7 days or with written veterinary clearance (this includes exposure to the animal shelter or dogs that have been in a shelter over the past 7 days).

BEHAVIOR: All dogs must be non-aggressive & not be food or toy protective. Owners will certify their dogs have not harmed or shown any aggressive or threatening behavior towards any person or any other dog(s). PLD reserves the right to deny admittance to Owner's pet for any reason at any time.

DAYS & HOURS:

Daycare: Monday-Friday 7:30 AM-6:00 PM. Check-in is between 7:30 AM -9:30 AM. Check-out is any time before 6 PM.

Boarding: Weekday check-in/out 7:30 AM – 5:30 PM. Saturday & Sunday is available by appointment: 8-9 AM or 5-6 PM.

RESERVATIONS: Required.

CANCELLATION: DAYCARE: (24) hours cancellation notice, otherwise Owner may be charged for the reserved service (by 9:30 AM the day before). BOARDING: (48) hour cancellation notice, otherwise Owner may be charged for a full night of boarding. HOLIDAY BOARDING: (72) hours cancellation notice, otherwise Owner may be charged a no-show fee equal to (2) nights of boarding.

LATE FEES: Owner will be charged \$1 per min after 6 PM or after scheduled time check in/out. This is NOT an add-on service. If Owner does not arrive before the PLD staff has completed its duties Owner will be responsible for late fee, food & boarding fees.

PAYMENT: Payment is due at the time of pick-up. Cash, Check, Visa, & MasterCard are accepted. Express Check-Out/Pre-paying available option. Pre-paid daycare expires (3) months from purchase date. NSF fee \$25.

PHOTOGRAPHY: Dogs may be photographed, videotaped, streamed live via webcam, and/or used in any media or advertising.

ABANDONMENT: If Owner does make contact with PLD within (5) days after the day the pet was due to be picked up, the pet shall be deemed to be abandoned and necessary steps will be taken to turn the pet over to the proper authorities. This action will not relieve the Owner from paying all charges for services rendered & all legal and/or costs incurred with collection for services.

RISKS:

- The Owner shall hold harmless PLD, its staff, volunteers and assignees for any damages or liability. PLD shall provide quality and reasonable care for the pet delivered by the Owner to the pet care provider, but cannot provide constant observation of every dog. Owner recognizes and accepts potential risks involved in daycare and understands and agrees that dogs can sometimes receive cuts, scratches, nips, bites, injuries from rough play, contract canine cough, etc.
- PLD is not responsible for any accidents due to Acts of God. PLD is not responsible for any theft. It is expressly agreed by Owner and pet care provider that PLD's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.00 per animal admitted.
- If dog becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, PLD, in its sole discretion, may engage the services of a veterinarian or administer medicine. The expenses thereof shall be paid by the Owner.
- The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet.
- The owners agrees that PLD will not be liable for problems, damage, or injury caused by the dog provided reasonable care and precautions are followed by day care staff. The owner releases PLD of any liability arising from the dog's attendance and participation at the daycare. The owner understands that the daycare is a place where animals co-mingle in groups. The owner understands that the dog may be placed in a crate for "time outs", for overnight care or if injured. Daycare staff may or may not notify the owner immediately. If the injury is serious, the owner will be notified immediately.

This Agreement contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and PLD.
